The bidder shall furnish satisfactory evidence to establish that bidder meets the qualifying requirements.

SECTION II: INSTRUCTIONS TO BIDDERS

1.0 **DEFINITIONS**

The terms used in this bidding document shall have the meaning defined hereunder:

- 1.1 "The Project" or "The Works" means supply of PM10, PM2.5, Spectrophotometer and Digital Balance
- 1.2 "The Board" means the Chhattisgarh Environment Conservation Board (CECB), having its office at Chhattisgarh Environment Conservation Board (CECB), Payable at HO, CECB, Nava Raipur, Atal Nagar (CG) and shall include any person or persons authorized by the Board. The Board is also executing agency of the Project. "The Owner" means the Board.
- 1.3 "The Bid" means the offer or proposal of the Bidder to be submitted for the works in accordance with the stipulations set forth in this Bidding Documents.
- 1.4 "The Techno-commercial Bid" means the Technical part of the Bid.
- 1.5 "The Financial Bid" means the financial part of the Bid.
- 1.6 "The Bidder" means either the manufacturer of the Equipment or his authorized Representative, who submits the Bid for the Works.
- 1.7 "The Contractor" or "The Contractor" means the Bidder, whose Bid for the Works has been accepted by the Board and includes his personal representatives, successors and authorized assignees.
- 1.8 "The Manufacturers" mean the firms, which produces the equipment to be furnished by the Contractor under the Contract with the Board.
- 1.9 "The Bidding Documents" mean all the documents in tender document.

2.0 ELIGIBILITY CRITERIA

Following documents are required to be submitted in **Envelop A** otherwise the officer shall be liable for rejection.

- 2.1 The bidder shall provide exclusive company profile including necessary certificates / license for manufacture the product from DGTD / SSI/SIA etc.
- 2.2 Enclose copy of PAN CARD of the firm.
- 2.3 Enclose copy of valid GST Registration certificate.
- 2.4 Enclose Bidder's Information as per Annexure A-1.
- 2.5 Enclose original copy of Demand Draft (DD) of Earnest Money Deposit (EMD).
- 2.6 The Bidder must not be blacklisted/ suspended or having service related dispute with any Govt. Organizations or Bank in India or outside India or any litigation pending as mentioned in Annexure A-2.
- 2.7 Enclose Power of Attorney as mentioned in Annexure A-3.
- 2.8 The bidder should also submit separately acceptance of Tender Terms & Conditions in company letter head as mentioned in Annexure A- 4.
- 2.9 The bidder's Annual Business Turnover for last three financial years ie. 2016-17, 2017-18 & 2018-19 should not be less than Rs. 2 crores PA. (Enclose copy of Audited Annual Accounts) Declaration as per Annexure A-5.
- 2.10 The bidder should have submitted filed ITR for last three years i.e. A.Y. 2016-17, A.Y. 2017-18 & A.Y. 2018-19. (Enclose copy of Acknowledgments.) Annexure A-5.

3.0 EARNEST MONEY DEPOSIT & SECURITY DEPOSIT:

While submitting bid, the BIDDER shall deposit an amount mentioned in tender document as Earnest Money, with the CECB through the following instruments:

Further, if the successful tenderer fails to furnish the required performance security within the specified period, its EMD will be forfeited.

5.0 PROCEDURE FOR SUBMISSION OF BIDS/TENDERS:

Each tenderer shall submit his offer in three sealed Envelopes A, B and C. Envelope "A" shall contain Earnest Money Deposit (EMD) and tender Fee, if the tender document is downloaded from the web site. The Envelope "B" should contain technical specification, terms & conditions, company profile, copy of sales tax registration number, PAN number and authorization certificate from manufacturer for submission of offer for this tender, if offer is submitted by authorized representative. Envelope "C" shall contain financial offer.

5.1 Envelope – "A" : Envelope "A" should contain demand draft for the requisite amount of Earnest Money Deposit (EMD) in favour of Member Secretary, Chhattisgarh Environment Conservation Board (CECB), North Block Sector-19, Nava Raipur, Atal Nagar Raipur (C.G.) 492002. If the tender document is downloaded from web site, then separate Demand Draft for tender Fee shall be submitted with Envelope" A". Envelop A should also contain the documents related to eligibility criteria as mentioned in Point No. 2 of Section II. The name of instrument and the amount of the demand draft should be inscribed on the top of

Envelope. Envelope "A" & "B" shall be opened on 03/02/2020 at 4.00 pm in the presence of the tenderer or their authorized representatives. Insufficient amount furnished as earnest money and tender cost shall make the offer liable for rejection.

- 5.2 Envelope "B": The Envelope "B" should contain detailed technical specifications make & model of the equipment, functioning procedure of the equipment and other literature relevant to the equipment and company profile. If the offer is submitted by authorized representative, he should submit authorization letter in Envelope "B" from the manufacturer for submitting offer for this tender, otherwise tender offer of the firm shall not be considered and liable for rejection. The tenderer should furnish users' list and details of supplies made by him to important institutions along with performance certificate. The tenderer shall have to submit the copy of sales tax registration and income tax no. [PAN] along with the Envelope "B", otherwise the offer shall be liable for rejection. An undertaking shall be submitted by the tenderer, regarding whether they are not black listed in any Govt. organization / institutions, along with Envelope "B". The details of service station in Chhattisgarh and India should be furnished with other details. Envelope "A" & "B" will be opened on dated 03/02/2020 at 4.00 pm.
- 5.3 Envelope "C" : The Envelope "C" shall contain financial offer as per Section VIII "Format of Price Bid" of the tender document shall be submitted online only. Offers received in due time shall be evaluated technically by a committee constituted by the Member Secretary, Chhattisgarh Environment Conservation Board (CECB) and as per the recommendation of committee, depending upon the suitability of equipment with respect to application, performance, after sale service and service centres in Chhattisgarh or in India etc., the date of opening of financial offer will be informed to Technically selected bidder only and negotiation will be done thereafter. Notwithstanding anything stated above the competent authority of the Board reserves the right to assess the capability and capacity of the tenderer to perform the contract, should the circumstances warrant such an assessment in the overall interest of the Board.
- 5.4 The Quotation MUST BE ENCLOSED IN A SEALED COVER super scribing Tender number / due date & should reach the undersigned on or before due date mentioned in the tender notice. If the quotation cover is not sealed, it will be rejected.
- 5.5 Tender should be submitted online as well as in the tender box in hard copy kept in

the office of mentioned Department. No tender is to be handed over to our staff personally unless otherwise specified. All communications are to be addressed to the undersigned only. In case due date happens to be holiday the tender will be accepted and opened on the next working day.

- 5.6 The bid can be submitted in person or through post/ courier (CECB shall not be responsible for any postal delays or any other reason for not submitting the bid in the specified time and resulting in disqualification / rejection of any bid) so as to reach on or before the due date and time.
- 5.7 The leaflets catalogue, etc. should be sent invariably so that a proper evaluation of the equipment offered is possible.
- 5.8 After acknowledgement of the LoI by the selected bidder, a Performance Bank Guarantee of 10% of contract value has to be deposited within 15 days in the form of Bank Guarantee (BG) of any nationalized\Scheduled Bank in the name of The Member Secretary, Chhattisgarh Environment Conservation Board (CECB), North Block Sector-19, Nava Raipur, Atal Nagar Raipur (C.G.) 492002, as per format given in Annexure A-6 till the completion of the project and shall sign the Agreement within 15 days from the issue of LoI.
 - NOTE: If the office happens to be closed on the last date of submission of the tender as specified in the tender, will be received and opened on the next working day at the same time and venue.

6.0 Price bid:

- 6.1 Price quoted should be in Indian Rupees, free pick up & delivery to CECB as per the list enclosed.
- 62 Prices should include all taxes like GST, sales tax, excise tax or any other taxes applicable.
- 6.3 Price quoted should include the price of the instrument as well as the cost of service & maintenance of the instrument for next 2 years (excluding 02 years of warranty).

7.0 Evaluation process

- 7.1 Chhattisgarh Environment Conservation Board (CECB) will constitute a Tender Evaluation Committee to evaluate the responses of the bidders.
- 72 The Proposal Evaluation Committee constituted by the Chhattisgarh Environment Conservation Board shall evaluate the responses to the TENDER and all supporting

documents / documentary evidence. Inability to submit requisite supporting documents / documentary evidence, may lead to rejection.

- 7.3 The decision of the Tender Evaluation Committee in the evaluation of responses to the TENDER shall be final. No correspondence will be entertained outside the process of evaluation with the Committee.
- 7.4 The Tender Evaluation Committee may ask for meetings with the Bidders to seek clarifications on their proposals.
- 7.5 Financial bids of only those bidders, whose bids are found technically qualified, by the Technical Evaluation Committee, will be opened in the presence of the vendor's representatives subsequently at a later date for further evaluation.
- 7.6 The Tender Evaluation Committee reserves the right to reject any or all proposals on the basis of any deviations.
- 7.7 Each of the responses shall be evaluated as per the criteria and requirements specified in this TENDER.

8.0 TENDER OPENING

- 8.1 The Bidding will be in three parts through E- Tender system. The tender committee will open the Envelope A containing Earnest Money Deposit (EMD), tender fee & qualifying document.
- 8.2 If found, that the bidder has furnished all the documents in the prescribed manner, then the second Envelope - B containing Technical Proposal will be opened by the tender committee.
- 8.3 The Financial/commercial proposal would be opened only of all the technically shortlisted bidders. The Evaluation Committee or its authorized representative will open the Financial Bid online. Sequence of online Bid is as follows:
 - [i] Envelop A EMD, tender fee & qualifying Documents
 - [ii] Envelop B Technical Documents
 - [iii] Envelop C Financial/Commercial Bid

9.0 LATE BIDS:

CECB will not be responsible:

- [i] For delayed / late quotations submitted / sent by post / courier etc.
- [ii] For submission / delivery of quotations at wrong places other than the mentioned

in the tender.

- [iii] Fax / E-mail / Telegraphic / Telex tenders will not be considered.
- [iv] Any bid inadvertently received by CECB after the deadline i.e. due date & time for submission of bids, will not be accepted and returned unopened to the BIDDER.

10.0 VALIDITY OF THE OFFER:

180 Days from the date of opening of the Technical bid.

11.0 TRANSFER AND SUBLETTING:

The seller shall not sublet, transfer, assign or otherwise part with the acceptance to the tender or any part thereof, either directly or indirectly, without the prior written permission of the Purchaser.

12.0 EVALUATION OF OFFER:

- 12.1 CECB evaluate technical and commercial acceptable offers on landed net Price basis.
- 12.2 Offer which deviates from the vital conditions (as illustrates below) of the tender shall be rejected:
 - a) Non- submission of complete offers.
 - b) Receipt of offers after due date and time and or by email / fax (unless specified otherwise).
 - c) Receipt of offers in open conditions.
- 12.3 In case any BIDDER is silent on any clauses mentioned in this tender documents, CECB shall construe that the BIDDER had accepted the clauses as per the invitation to tender no further claim will be entertained.
- 12.4 No revision in the terms and conditions quoted in the offer will be entertained after the last date and time fixed for receipt of tenders.
- 12.5 In case of two bid system the date and time of Price Bid opening shall be intimated to technically qualifying bidders only.

13.0 DEADLINE FOR SUBMISSION OF BIDS:

Bids must be received by CECB before the due date and time at the address specified in the fact sheet of tender document. In the event of the specified date for the submission of bids being declared as a holiday for CECB the bid-closing deadline will stand extended to the next working day up to the same time.

14.0 COST OF BIDDING:

The Firm shall bear all costs associated with the preparation and submission of its Bid and the Purchaser shall not be responsible or liable for those costs regardless of the conduct or outcome of the bidding process.

15.0 AMENDMENT OF BIDDING DOCUMENTS:

- 15.1 At any time prior to the deadline for submission of bids, CECB may, for any reason, whether on its own initiative or in response to the clarification request by a prospective BIDDER may modify the bid document.
- 15.2 All prospective BIDDER who have downloaded the bidding document may visit CECB, website for amendments / modifications which will be binding on them.

16.0 CANCELLATION OF TENDER:

Notwithstanding anything specified in this tender document, Purchaser / CECB in his sole discretion, unconditionally and without having to assigned any reasons, reserves the rights:

- a) To accept or reject lowest tender or any other tender or all the tenders.
- b) To accept any tender in full or in part.
- c) To reject the tender offer not confirming to the tenders terms.
- d) To give purchase preference to Public Sector undertakings when applicable as per Govt. Policy/Guidelines.

17.0 PERFORMANCE GUARANTEE (PG)

- 17.1 The successful bidder shall have to submit 10% amount of the total contract value as performance security in the form of Bank Guarantee for a period of 12 months which shall be retained with CECB till the expiry of guarantee period.
- 17.2 Performance Guarantee of a tenderer will be forfeited, if the tenderer withdraws or amends its tender or derogates from the tender in any respect within the period of validity of its tender.

18.0 TERMS AND CONDITIONS - AWARD OF CONTRACT:

- 18.1 Only L1 supplier shall be selected for this tender.
