TERMS & CONDITIONS OF AUTHORIZATION

1. M/s Dhruv Tara Associates, Near Old Bus Stand, Nirala Nagar, Distt. - Bilaspur Chhattisgarh is hereby granted One Time authorization for Import of Aluminium Scrap (Schedule III, Part - D, Basel No.-B1010) Capacity 6000 MT/Year Of Hazardous & Other Waste (Management & Transboundary Movement) Rules 2016.
2. The authorization is valid for import of Aluminium scrap on behalf of actual user as per Schedule III, Part - D, Basel No.-B1010 of Hazardous & Other Waste (Management & Transboundary Movement) Rules 2016.
3. The authorisation is subject to the conditions and sub conditions stated below and conditions as may be specified in the rules in force under the Environment (Protection) Act, 1986.
4. The occupier of the storage facility/Importer shall obtain necessary permission from Chhattisgarh Environment Conservation Board for temporary storage of metal scrap if intended to store the materials in Chhattisgarh.
5. The import is permitted only on behalf of actual user M/s Gangotri Metal & Alloys (India) Pvt. Ltd, Kanhera Road, Village- Achholi, P.O.- Urla, Raipur with valid consent from Chhattisgarh Environment Conservation Board / traders having registration from CECB. In case of high sea sales by importer the bill of entry shall be filled by actual user / registered traders. The importer shall submit quarterly report in form - 10 Including quantity of metal scrap imported with documents for bill of loading, Bill of entry, quantity sold to actual users and submit annual returns in form - 4 as per Hazardous & Other Waste (Management & Transboundary Movement) Rules 2016. The manifest system as per rule 19 (i) in the Form No. 10 shall be implemented after reporting imported scrap at ports.
6. In case of illegal import or import other then mentioned in Schedule III, Part - D, Basel No.- B1010 of Hazardous & Other Waste (Management & Transboundary Movement) Rules 2016 the waste has to be re- exported by the importer at his own cost within a period of 90 days from the date of its arrival in India.

General Conditions:

1. The trader authorized shall comply with provision of the Environmental (Protection) Act 1986, and the rule made there under, The authorization shall be produced for inspection of the request of an officer authorized by the Chhattisgarh Environment Conservation Board.
2. The person authorized shall not rent, land, Sell, Transfer or Otherwise transport the Other Waste without obtaining prior permission of the Chhattisgarh Environment Conservation Board, Any Authorization change in personal or working Conditions as mentioned in the application by the person authorized shall constitute a breach of the authorization.
3. Any unauthorized change in personnel, equipment or working conditions as mentioned in the application by the person authorized shall constitute a breach of his authorization.
4. It is the duty of the authorized person to take prior permission of the CECB and to close down the facility. An application for the renewal of Registration shall be made as laid down in the rule of Hazardous & Other Waste (Management & Transboundry Movement) Rules, 2016.
5. The Other Waste materials must be stored to prevent unauthorized people from accessing the area.
6. The Board reserves right to cancel /amend /revoke the authorization at any time as per the policy of the Board / Government.
