Whereas, a notice was served to your industry vide reference mentioned at s.no. 4 by Chhattisgarh Environment Conservation Board, wherein the unit was directed to show cause why a sum of Rs. 4,00,000/- (Rs. Four Lacs only) should not be imposed towards environmental compensation for not complying with the provisions of HOWM Rules, 2016.

Whereas, Central Pollution Control Board has approved the financial penalty of Rs. 4,00,000/- (Rs. Four Lacs only) vide reference mentioned at s.no. 6 as environmental compensation imposed by CECB. A copy of the same has been endorsed to your industry also.

Now therefore, in exercise of powers under rule 23 of the HOWM Rules, 2016 the unit is here by directed to deposit a sum of Rs. 4,00,000/- (Four Lacs only) through DD in favour of Member Secretary (EC), Chhattisgarh Environment Conservation Board immediately, failing which CECB will be constrained to initiate action against the unit without giving any further notice in accordance with the provisions of the Environment (Protection) Act, 1986.
